

Once you have entered your name to replace the templates name, you have achieved the magic if your name now appears in replacement and remains shaded in grey as the original was.


To be removed from your current template are the following. Annexure A; Annexure B; Annexure E; Annexure H and Annexure I. To do so replace the options in reverse so they move upwards or rename the Annexures in the following. If you have downloaded a version with these removed, the same application can be done to add or remove 'Annexures' or paragraphs.

You may still include the previous methods and links if you choose, note there have been some issues and one site has been unable to send through finalization of your record. Which has hindered some people from completing their Affidavit.






Currently as of August in the year known as 2023 the following Annexures will be obsolete from Affidavits as there are now alternatives to 'recording' your details in a court of record through 'The Peoples's Court of Terra Australis'. If you have the previous Annexures you can still include them if you wish to do so.

	You want an Affidavit because if you don't have an affidavit in their system, you don't exist in their system. That's because the only thing that exists in their system is a "fictional name" your "capitalled lettered name or your surname" because that's how they have created these trust accounts. Refer to Fraud videos on the website. If you don't have a presence in their system they will only treat you as the "fiction", they can't treat you as a 'living man or living woman'. This will now give you protection from them committing what is called "personage" or for matters in court it is called "barratry" if they treat you as a fiction. Before you commence editing your very own Affidavit I suggest you purchase a designated USB to keep this file and all other templates on it for ease of printing at 'printing store'. This will also ensure your online 'privacy and security'. This will also come in handy to store your templates for future use and to store the online available dictionaries and statutes, you will definitely be referring to several times from now on.

I encourage you to research the new terminology you are learning and catch up on past recordings on the channel mentioned previously.

Great idea if you want to work on it offline or remotely. Even your very own backup as there may be attempts to remove our access to learning. You may even attempt to download the best videos as a resource.

At the end of this guide I have included a Reference section including a Glossary to help you on your way of learning lore folks.

Once you start editing your own document, rename the file to be your very own.




Rename the file (use "Save As") so you know which version is yours and not the original blank template – for example, change the filename from 'Freedom Affidavit Template' to Freedom Affidavit – Tilly. This makes it so much easier when there are more than one of you on board and working on their own individual Affidavit in the household using one computer / USB.


Also remember to press the disk icon or "save" the document frequently, you



#### **Usage Instructions**

While these instructions may be lot to read, however investing the time to read this section will be beneficial for you. How long will it take? How long is a piece of string. Every piece of string may be different.

If you're upgrading to the latest version of this document, **don't copy/paste** your way into a reformatting nightmare – just redo steps into a blank/fresh template. Enter Your Details and Review and Edit – it will be way faster!


Once again rename file and use 'save as' and perhaps add a date

That's if your printing shop, Australia Post and the JP are under ten minutes drive from you, so add transit time if required

2 trips to the print shop (5mins the first time, and 45mins the second

time);

2 trips to Australia Post (pretty fast, just queuing time); 1hour with the JP





## Download and install LibreOffice

It's free, open source, works just like Microsoft Word and Excel, as it handles the document automation tricks making this template easy.


<u>Rename the file (or use "Save As")</u> so you know which version is yours and not the template – for example, change the filename from "Freedom Affidavit Template" to "Freedom Affidavit – Tilly"

Note that for your privacy, this document can be edited offline, because it is entirely self-contained and makes no connections outside itself. Which mean the hyperlinks are not connected.

#### **Enter Your Details**

You might also have to fix up the formatting here and there. Be careful to use the same capitalisation, punctuation and spacing as the examples given, however to reduce errors for our *Find and Replace* people, we've added an "x" at the end of some fields to make them unique, so just make sure your new value doesn't have the "x"

If you can't complete a section or are not sure of what it requires, I suggest you highlight the area and come back to it. Don't let that part stop you from getting further ahead. Any information we don't know simply write in 'not known' as in paternal/maternal grandparent names, if applicable enter 'unknown'. There is no need to panic, just answer with what information you do know. As you are affirming to this with this document that this, "is the truth" as you know it to be.



It is now time to gather your images, relevant certificate numbers and have them ready on your USB ready to upload as required.



### How to copy and paste and why do we need to:


Lets say that you have more than one known fictitious name; whether you have changed your name by "Deed poll", by 'marriage' or 'marriages', even by 'adoption'. These collective names and aliases all lead to more fictitious "Cestui que vie" trust accounts. You may also have more children you wish to include in your Affidavit to cover them. So these may be two instances where you may need to copy and paste paragraphs or text boxes. Note: this may alter the paragraph numbers. This can be avoided by entering more blank lines between paragraphs prior to copy and pasting sections.


#### **Review and Edit**

1. Add your family flag and/or crest at the top of page 1 (of the actual Affidavit Template,) and your photograph at the top right (right-click on the image and select "Replace")



then find your images to insert them into position. Feel free to format and configure how big you would like each to be, prior to printing you may also use the Print preview option to see how each page, especially this one will look. It will now look like this GO Statement and Declaration of Truth "Affidavit" of 'Sam Sol' and/through the living man we are incarnated into: 'John Robert', of the tribe/family/house/clan "Smith",





You can mock up an image of your identification plates at Mr Plates or Pimp My Plate which you can copy/paste into paragraph 118

Later when you get your plates: Remove the government plates, don't just stick your plates on top Keep the government plates and if they ask, tell them you're keeping the plates as evidence in a case of fraud

- 6. Note that if you delete a paragraph, the links to subsequent paragraph numbers will change, and of course any links to the deleted paragraphs will then say "Error: Reference source not found" which is expected
- 7. If you have children, update paragraph with your children's names
- a) Edit "loins/womb" as appropriate for your gender
- b) If you don't have children, just remove the second half:
   "including but not limited to ...(children's names)... and all variations of such"
- 8. Review and edit section Re: The "Soul", the relevant paragraphs if your metaphysical beliefs differ
- **9.** If you live outside Victoria, replace "VICTORIAN GOVERNMENT" in paragraphs 90 and 91 to one of the following:
- a) "THE NORTHERN TERRITORY"
- b) "QUEENSLAND"
- c) "AUSTRALIAN CAPITAL TERRITORY" and/or "THE AUSTRALIAN CAPITAL TERRITORY"

**10.** If you live in NSW, SA, WA, or Tasmania, there's no equivalent 'Nonc', 'Nret' entity for your state, so just delete paragraphs 90 and 91, because you're already covered by paragraphs 92 and 93. You can double check this by searching for your state in Illion (Dun and Bradstreet) then filtering down to Nonc and Nret

# Note that if you do this before the other edits above, the paragraph numbering will change

- 11. In Annexure "C" Visual Image of the Living Being: replace the images with three different visual aspects of yourself, for example a passport photo, a side profile, and a professional "work" photo
- **12.** In Annexure "D" Schedule of Fees for Remedy:
- a) Replace the image at the top left with your flag (right-click on the image and select "Replace") refer to example above where the flag and photo were inserted into the document in step 1.
- b) Optionally, replace the court seal at the top right with your own court seal





#### Pets

By this stage you have become familiar with the ins and outs, you may now wish to add your pets, we may even include livestock in a future revamp.

Once again go the Book of Deeds and select the Record of animals.

#### **Prepare and Print**

Find a Justice of the Peace or three witnesses who have known you for twelve months

Look for a dedicated JP stand (eg: at your local shopping mall) as hopefully they'll have nothing better to do than initial all your pages of affidavit


You'll often find a pharmacist who is a JP too, but they'll be rushing about trying to serve customers so you'd better warn them that they will need to initial all the pages.

If you are using a JP, edit the First Witness autograph block to remove the line that says they've known you for 12 months, and remove the Second Witness and Third Witness autograph blocks refer to following visual instructions.

#### Excess Witness removal from document


Then you would cutout the second and third witness if you were going to get the JP to certficate.



Imagine you highlighted a line and accidentally pressed a key and instead of highlighting, you deleted the line. How can you fix it, if you can't remember what it said?

You will see that the line you highlighted has now been erased. Did you know if you make a slight mistake, you are able to take a step back, usually the back arrow on the taskbar above in the word processor application.

You can also use COMMAND + Z or CTRL + Z. Have a look online for special shortcut keys that can save you time and stress for your specific platform whether Android, Apple or Windows



You may get used to using this command key and the letter. This is another form of shortcuts that will be useful in your creative writing journey.



## Printing

1. Get a printing shop like Officeworks to cut down a ream of A3 paper to foolscap size, or do it yourself if you have a guillotine cut the whole ream down to size and store neatly into the original packaging. You will also now have two different strip lengths of paper to turn into note paper. Apparently some print shops are refusing to cut down to 'foolscap' so you might just prepare in advance and have the dimensions ready for them to follow and cut down to size.



- a) The tricky bit is that there's quite a few sizes of foolscap when you do an online search. However the only thing we need to do is make sure we're not using A4 as it is considered the corporate world's copyright.
- b) This document is formatted for "Traditional British" foolscap size (203x330mm / 8x13") but you can easily enough change the page size before printing. If your budget is tight, you can also trim off some of the top or the side of A4 paper, or cut the corners off, this also allows you to use paper from your "kingdom" not a size that is 'copyrighted'.
- While you're there, you might also want to buy a stamp-pad of red ink, if you don't already have one, for your fingerprint (unless you prefer to use your own blood)

- 2. Print just the affidavit and annexure pages on your freshly cut foolscap paper or alternative size.
- a) **Print in colour** (not black and white) **so it comes out in purple like you see on the screen. Copies are ok to be done in black and white.**
- b) No need to include the instruction/helper pages and the last page (cover letter) in your affidavit
- c) And <u>don't print the cover letters at the end</u> just yet you'll only want to print those for your state, and you'll probably want to change to A4 paper for them
- 3. Practice your new "autograph" (signature) for your soul and your living man/woman (just your given names, no surname)

2. Go to the post office and buy enough prepaid envelopes to send to each recipient Get the large red+orange ones that are registered mail with tracking You'll need the larger envelopes because you'll exceed the maximum thickness on the small ones Buy in packs of 10 because they're cheaper, and you'll use the spares soon enough As a guide, 2 packs of 10 envelopes cost around \$145



Another alternative is to purchase in bulk, your local postal outlet may have them or you can order them in store or online. A "Box of 50 Registered Post Prepaid Labels" are currently available for around

\$204 (approx. \$4 per label), this entitles you to use the labels on any size envelope and the "Registered Post fee has been prepaid. <u>Postage is not included</u>. You can now buy any bulk envelope package to suit your needs. Just remember certain size envelopes can contain a certain thickness. So I recommend the larger document size envelopes for the Affidavit and document mailing.



If you are going to a JP may I suggest you also obtain atleast 20 copies of your 'Birth Certificate" to use as "certified copies" which are then known to be certified "true" copies of the original. Never hand in your original, you may not get it back, it may even land in a shredder. Original certificates are getting harder to source. Take care of them.



On a zoom it was mentioned someone put their PO BOX as a location address this is how to write it.

Example PO box 125 Kew, Victoria 3189 we write: 125/(street number of the post office)high

So see if you can take a photo of your parents and grandparents certificates, these are good to have for your own library of information. You can save them onto your USB and make a folder for 'Family Lineage'



Evidence given to explain, repel, counteract, or disprove facts given in evidence by the adverse party.

## Principal

The source of authority or right. PRINCIPAL, n. The source of authority or right. A superintendent, as of a school district. The capital sum of a debt or obligation, as distinguished from Interest or other additions to its The capital sum of a debt or obligation, as distinguished from Interest or other additions to it

## Agent

A person authorized by another to act for him, one entrusted with another's business. One who represents and acts for another under the contract or relation of agency, A business representative, whose

#### Impecunious

#### Malfeasance

#### **Biological creators**

Are what we are accustomed to saying they are our 'parents'

#### "Terra Australis"

From latin '*TERRA*' means earth, land. '*AUSTRALIS*' means southern. The great southern land.

## Appellation

A name, title or title. Here it signifies the 'name by which your (mother) biological creator called you by since being born.

## **Military Titles**

Appellations as they are commonly used in society "Mr", "Ms", "Mrs" "Mx", "Miss", "Master", "Matron", "Sister" as they

**Live-born biological creation** The offspring of maternal and paternal creators, otherwise known as parents.

#### Two languages on one document

If there are two languages on one document the document is void as per the 'Chicago Manual of Styles'. One obvious limitation of the use of Glossas from the spoken/written language to represent signs, is that there is no one to one correspondence between the words or signs in any two languages.

## Glossa code = Dog Latin

Corrupt use of language, hidden foreign text to deceive. Corruption of the

text. Presented in all uppercase text. Also named d-based latin. Was Ancient Latin traditional language of the Vatican, with one mark between words to make up a phrase.

**Dominion** - Authority

**Natural Person** A fiction that is not a physical living man or living woman and only exists in written form.

#### Autograph versus signature

Avoid using signature, if registered as part of your 'ID' in the corporate system, it is also connected to your legal fictional name and 'Capitalled Letter' entity. Signatures equate to X crosses. By signing contracts or forms you become the 'debtor' of the bank. By signing you now allow the 'bank' to become the creditor.

#### Jurisdiction

The authority of the court or organization to make decisions or judgements.

## Psyops

Mind control, hypnosis or any other form of mental, emotional, psychic or spiritual influence tactics/strategies/programs/campaigns

**Estoppel by Acquiescence** (permanent and irrevocable) Is applied when one party gives legal notice to a second party of a fact or a claim, and the second party fails to challenge or refute that claim within a reasonable time. The second party is said to have acquiesced to the claim, and is estopped from later challenging it, or making a counterclaim.

#### Estoppel

Precludes a respondent from denying that it has consented to the tribunal's jurisdiction. A legal doctrine that holds that a party can be stopped from doing something that is inconsistent with their previous actions or with a judicial determination that has been previously made. It essentially prevents a party from going back on their word.

## Acquiescence

Passive acceptance or submission. It is an expression of consent (through silence or conduct).

Tacit - Understood or implied without being stated

Amnesty period of twenty-eight days the time in which they are permitted to rebut 'Affidavit'

**Canon laws** – Is the body of rules governing, they were made by ecclesiastical authority for the government of a Christian organization or church and is members.

**Public Record** – where you can have details recorded such as Book of deeds for Living status or claim of Ficitious name

**Summonsed** - summons the dead, is the act of summoning; a acll by authority to appear at a place named or to attend to a duty.

**Custodians** – a person with responsibility for protecting or taking of something or keeping something in good condition

**Caretaker** – a keeper of the land, the work of being a caretaker.

Clerk of Guardians - clerk of "courts"

**Executor** - the person appointed to administer the estate of a person who has died leaving a will which nominates that person.

**Beneficiary** – the holder of an ecclesiastical or other benefice.

**Sum-certain** – referring to a specific amount (usually an amount of money) that is directly stated in a contract or negotiable instruments. (such as mortgage or promissory note)

Barratry – an unlawful act or fraudulent breach of duty.

**E & OE -** Errors and omissions excepted E&OE is a phrase used in an attempt to reduce legal liability for potentially incorrect or incomplete information supplied in a contractually related document

Without prejudice – is a term used in legal negotiations to the parties reach a settlement without going to court. A term used to allow a statement or proposal in communications, while allowing the party to return to their original position without being impeded by the described statement or proposal.

## Liability

Lawful responsibility for one's acts or omissions. "Fault" is a type of liability in which the plaintiff must prove that the defendant's conduct was either negligent or intentional.

## Nret
